WHAT TO DO IN THE FIRST TWO HOURS...		
NOW	Call 911...	<ul style="list-style-type: none"> Time is the enemy in the search for a missing child or person with Alzheimer's. When police arrive, GIVE THIS ID CARD TO THE LAW ENFORCEMENT OFFICER IN CHARGE - Make a note of the law enforcement officer assigned to your case - as things develop, he/she will be your partner in finding your missing person.
1st Hour	<p>Search the house and immediate area...</p> <p>Contact everyone who may know where your missing person could be...</p>	<ul style="list-style-type: none"> If your child or adult is missing from home, search the house checking closets, piles of laundry, in and under beds, inside large appliances, and inside vehicles, including trunks—anywhere a person might hide. Search the areas surrounding your home including storage sheds, gardens, surrounding yards, and out buildings. Speak to neighbors to see if they know anything. Go door-to-door in the area. Telephone family members and tell them to contact you if the missing person shows up at their house. Request that your missing person's name and identifying information be immediately entered into the National Crime Information Center (NCIC) Missing Person File.
2nd Hour	<p>Limit access to your home...</p> <p>Arrange for someone to be at your home if you have to go out...</p>	<ul style="list-style-type: none"> DO NOT touch anything in the missing person's bedroom. Common items such as clothing, sheets, personal items, computers, and even what's in the trash may give clues as to their whereabouts. This is important as the person may return home while you're out searching. Also, someone should be there to answer telephone calls. An answering machine will ensure you do not miss important messages when you are unavoidably away from the phone. It is wise to keep a detailed diary or log next to the telephone to record times, dates, names and telephone numbers of all incoming and outgoing calls and to note any other information relevant to the call. Such a log should also record what action had been taken and by whom.
